Call Circular for 2024-2026 Budget Preparation:

1.0 Preamble

As you may be aware, provision of section E of the 1999 Constitution of the Federal Republic of Nigeria (as amended), 'Powers and Control over Public Funds' provides that each state of the federation shall have cause to prepare an estimate of revenue and expenditure for the state for every Financial Year (FY), in this case the FY 2024. Equally, the Zamfara State Financial Instructions 2015 and Law Application to Zamfara state, Cap108 also enshrined the preparations and monitoring of annual estimates to the Ministry of Budget and Planning.

In accordance with the above provisions and on behalf of His Excellency the Executive Governor of Zamfara state, **Dauda Lawal** *(Gamjin Gusau),* the Ministry of Budget and Planning, hereby requests for submission of financial proposals for the 2024 fiscal year, as well as out year estimates for 2025 and 2026. Your submission is expected to cover projected revenue in-flows, as well as recurrent and capital expenditures. In regard to the above, you are requested to abide by the following, please: -

1.1 All submissions must be made to the nearest Thousand Naira.

1.2 The 2024 budget submission must be accompanied by 2023 budget implementation reports of your organization between January - September 2023, detailing revenues collected (*Internal Revenue Generated, Grants Collected from the Federal Government, Educational Trust Fund etc, External Donors; World Bank, USAID, UNICEF, UK-Aid etc.*) as well as expenditures (Recurrent and Capital) incurred during the period.

1.3 Our drive on opening up new as well as expanding existing sources of internal Revenues in the state is still in force. Thus, the State Internal Revenue Board will continue its efforts to ensure compliance. All revenue generating MDAs will get releases based on their performance on the revenue generation.

1.4 **IPSAS Formats and Templates:** MDAs are strongly advised to carefully study the formats and templates attached and exercise due diligence in providing all necessary information as required. *Please note that all proposals that are not in accordance with the above guidelines will not be accepted.* Should that happen, this ministry will have no option but to provide nearest feasible allocations for the affected MDAs. Attached to this is copy of the Budget Classifications for your guidance to that effect.

1.5 All MDAs are requested to submit their 2024 budget proposals and 2025 - 2026 out year estimates on **Excel spreadsheet (soft copy on flash-drives)**, as well as provide 12 hard **copies** to the Ministry of Budget and Planning, on or before **Tuesday 14th November**, 2023.

1.6 **Budget Bilateral Discussions:** The timetable for bilateral discussions will be forwarded to your office on or before **Friday 3rd November, 2023** for your guidance.

1.7 Honourable Commissioner, Permanent Secretaries and Chief Executives are strongly advised to lead their MDAs bilateral teams. Please ensure that all submissions meet specified requirements relating to format, contents, timeline, and adherence to MDA'S Establishment Law and State Procurement Law as well as government policy trust.

1.8 The state will give emphasis to Security, Education, Health, Agriculture and Social Protection as a way of driving development across sectors and communities in the state. In this regard affected MDAs of Security, Education, Health, Agriculture and Social Protection sectors are urged to craft people driven developmental activities and projects that will promote livelihood.

Guidelines for Preparing the 2024 Budget and the Medium Term Budget Framework 2024 - 2026(MTBF)

1.0 General Instructions:

In preparing the 2024- 2026 budget proposals all MDAs, are required to strictly adhere to the following general guidelines:

1.1 All budget proposals should capture a three-year planning horizon for the three fiscal years (FY) covering 2024-2026. Estimates should be provided for FY2024, while indicative projections should be provided for FY 2025 and 2026

1.2 In furtherance with our effort on meeting standard best practices on Public Financial Management (PFM), the Ministry is continuing with the adopted integrated approach to planning and budgeting within a multi-year framework. Government's decision to adopt the

preparation of the Economic and Fiscal Updates (EFU), Fiscal Strategy Paper (FSP) and Budget Policy Statement (BPS) is part of the movement towards a comprehensive Medium Term Expenditure Framework (MTEF) process. The 2024 - 2026 MTBF is a continuation of that movement process. The use of a combined EFU, FSP and BPS allows for projection of revenues and expenditures using a multi- year framework. Whilst the EFU provides an assessment of budget performance (both historical and current) and identifies significant factors affecting their implementation, the FSP on the other hand determines the resources available to fund Government projects and programmes from a fiscally sustainable perspective.

1.3 In line with the above practice, resource allocation for recurrent and capital expenditures has been outlined by the FSP. This forms the basis of the 2024 planning ceilings (budget envelopes) for MDAs.

1.4 Honourable Commissioners, Permanent Secretaries and Chief Executives of MDAs are advised to strictly observe the limits imposed by the ceilings and carry out all fiscal planning within the prescribed limits. This will remain the case unless there are fundamental changes in the underlying revenue assumptions of the state or where there are urgent and unpredicted changes in the process of preparing the new budget.

Macro-Economic Framework:

2.1 The Macroeconomic assumptions used in projecting the 2024 - 2026 estimates were based on the latest Nigerian National Real GDP growth and inflation (CPI) as estimated in the IMF World Economic Outlook publications. Oil benchmarks and recent NGN: USD exchange rates were also based on the 2024 - 2026 Federal Fiscal Framework document (by the Budget Office). Minor adjustments were made on inflation rate to suit expected position of the state.

2.2 The assumptions made are shown below:

2.3 The Macroeconomic framework is based on IMF World Economic Outlook (April 2023 edition), the United Nations World Economic Situation and Prospect estimates the state GDP per person (pp) and Inflation as well as Nigeria National Budget Office forecast for the 2024 - 2026 MTEF.

2.4 The IMF's April 2023 World Economic Outlook (WEO) the baseline forecast for global output growth is 0.1% point low than the predicted in the January 2023 WEO Update, before raising to 3.0% in 2024.

2.5 In the absence of state figures on Inflation rate, Zamfara adopted national figures as shown in the above table on inflation and an exchange rate of N462 was adopted as in the national MTEF for our medium-term plan.

2.7 The Federal Executive Council approved a benchmark crude oil price of \$70 per barrel for 2023, this is at a time the actual market price is fluctuating. The US Energy Information Outlook short term projection for crude oil price is around \$75 per barrel in 2024 taking into account the need to benchmark below market price, and using a discount of 25%, an estimated Benchmark price of \$70 per barrel is expected price and this is very close to the country's forecast of \$75 for the 2024 -2026 period. Going by happening in the country however, it is doubtful if our oil production benchmark of 1.5 million barrels per day will be achieved.

Policy statement

3.1 In continuation of its policy, this administration states the following:

• To provides security services across the state

- Creating sustainable development in urban and rural areas through the construction of accessible road networks, improvement of secondary and tertiary education, healthcare facilities to reduce diseases and mortality, as well as provision of other basic social services such as water supply, electricity and affordable housing,
- Improvement in Agricultural production through provision of farm inputs, implements and revival of irrigation schemes,
- Ensuring the achievement of sustainable Development Goals,
- Sustenance of good governance through effective development policies & budgetary, public finance management & public procurement reforms, sustainable department management and improve revenue collections and promotion of transparency & accountability by ensuring due process in government businesses as well as security for lives and property,
- To improve revenue generation through systematic blockage of leakages, harnessing and revitalising more sources to reduce overdependence on federal allocations and loans.

3.2 Economic Sustainability Programmes

Nigeria COVID-19 Action Recovery and Economic Stimulus:

- Provision of Social Transfers to poor & vulnerable groups, aged and chronically ill people with a view of uplifting their standard of living.
- Create jobs to unskilled youths through labour intensive public works programme.
- Provision of livelihood grants to poor and vulnerable households.
- Provision of basic services to communities through establishment/renovations of schools, healthcare facilities, water & and sanitation and nutrition.
- Food security programme through provision of basic agricultural inputs, farming assets, rehabilitation of wet markets and basic services to farmers.
- Provision of basic investment grants to micro businesses in the state.

Mines and Steel Development

- Create and support jobs along the mineral value chain in the state
- The project aims to develop artisanal and small-scale mining for economic growth and development in the state.

State Action on Business Enabling Reforms Programme

 Creating business enabling environment for business groups through enhanced land administration and provision of enabling policies and guidelines for businesses as well as provision of starter parks to business groups.

Jobs creation Strategy

- To create jobs through the construction of mass housing in the state.
- Easing bottlenecks in delivery of social housing using PPP.
- Job creation through National Public Infrastructure Maintenance Project
- Creating job opportunities to the citizen especially youths

Fiscal Strategy Assumptions

- 4.1 Forecast Assumptions:
 - a. Statutory Allocation –Elasticity based forecast was used as with revenue and distribution calculations used for federal revenues.
 Given the current happenings on prices of oil (and its attendant impact on federal state revenues), It is imperative that the state reduces its expectations from this end. Revenues from this Statutory Allocation continued with its upward trend in 2022 But in first half 2023 revenue performance report was 43.1% of the actual collections from January to June 2023.
 - b. VAT As with the statutory allocation, forecast for VAT is based on Electricity forecast estimates. This is the only indicator (VAT) that has performed modestly at about 111.06% in the reporting period as at December 2022.
 - **c.** Excess Crude- This revenue line item though not envisaged in the 2022 FY, but over six billion was realised as at December 2022. To this end we due emphasised our expectations on this source of revenue.
 - d. Internally Generated Revenue (IGR): A four-year weighted moving average was used as basis for IGR growth based on the FY2022 actual collections (Baseline). IGR collection in the state has been on the nominal decrease, to improves the performance revenues collection reforms needs to include upward review on rates and levies. But, even with this, the state needs as a matter of urgency re-strategized on how to improve its internal revenue generation to be able to meet up with our expectations.
 - e. In spite of this however, the low volume of economic activities occasioned by current security challenges as well as advert effect of crises has affected revenue collection in the state.
 - f. Grants- The forecasts are based on current commitment from Federal Government, Local Government, and the Development partners (including NG-CARES, UNICEF, DFID, the World Bank Group). Since grant funding is non discretional, these funds are tied to the implementation of specific programmers/projects. Due to its effect on programme implementation especially if funds are not realised, the state made zero anticipation on this head.
 - g. **Miscellaneous Capital Receipts** These include local government contribution to joint projects, national a forestation, UBE programme, SDGs, LNG receipts and deregulation

funds among others. Through their contributions to the state budget are not steady, they contribute significantly to the capital revenue formation.

- h. **Financing (Net loans)** The performance of loan receipt against budgets has been significantly high these years past. This is attributed to incidence of unrealistic flow of resources from other sources to the state. State Government in it's effort to reduce short term borrowings, only about 8.2% of the projected figure for loan was actually collected up to the end of first half of the year, which is highly recommendable.
- i. The absence of a clear policy on loan by government is an issue affecting budgets and budget implementation negatively in the state. Additionally, this makes it difficult to realistically project funds required on this revenue line item.

The 2024 Budget Focus:

5.1 The government will focus on sustaining and improving the progress made over last few years on economic development. The 2024 budget will seek to diversify the economy through the promotion of indigenous production, processing and exportation of agricultural produce.

Specifically, the budget will focus on:

2024 Budget Focus:

- Enhancing Security, Law and Order.
- Improve Human Capital (Education & Manpower Development, Health and Nutrition and Youth and Women Development).
- Create Enable Business Environment, Trade and Technology
- Improvement in Agricultural and Water Resources (Agriculture, Food Security and Rural Development & Water Resources and Sanitation).
- Infrastructural development (Housing and Urban Development, Manufacturing & Indoctrinations and Improved Transportation).

5.2 Submissions for 2024 budget should be guided by:

- The policy thrust of the state government.
- Overall stated focus of 2024 budget.
- Trend and past experience.
- Specific mandate of MDAs.
- Medium Term Sector Strategies (MTSS).

b. Strategic overview of the Ministry/Department/Agencies (MDAs):

MDAs should provide supplementary information on the under-listed (ZAM Budget F06):

- MDA Goal and Vision,
- MDA Core Functions,
- Policy Outcome Indicators and Targets,

• Specific objectives of the budget proposal and how they address state policy statements.

5.3 Similarly, MDAs should keep in view the following considerations while preparing their budgets

- Boosting Internal Revenue Opportunities and Inclusive Development,
- Transparent and Accountable Governance,
- Completion of On-going projects,
- Sustainability of on-going programmes/projects by way of capturing anticipated recurrent costs elements in the medium and long-term frame.

Revenue projections:

Revenue proposals should follow the format prescribed in ZAM Budget Form 01. Revenue generating MDAs in the state are encouraged to prepare their revenue estimates and targets as well as take necessary measure to achieve the targets.

6.1 All revenue generating MDAs are advised to make very realistic revenue projections based on all exploitable revenue potentials for 2024 fiscal year. MDAs are required to submit proposals for the review of obsolete rates, fees and charges collected on goods and services rendered to the public and for the introduction of **new revenue activities/sources to the state Board of Internal Revenue.**

6.2 All revenue projections for the 2024 Fiscal Year should be submitted on Form ZAM Budget Form 01

6.3 Actual revenues collections made up to 31st August, 2023 should be shown in the appropriate columns on ZAM Budget Form 01. This will be compared and analysed with the indicative revenue projections for the years 2024.

6.4 **MDAs and chief Executives are reminded** that failure to disclose collections from all sources (Local generation, External Donors/Draw Downs etc) to the Accountant General's office are advised to desist from doing so, because it's a gross miss-conduct.

6.5 The 2024-2026 Mid Term Expenditures Framework were fashioned from the below forecasts comprising of the expected revenue inflows as well as expenditures for the 3 year period. The details of the ceilings together with sectorial breakdowns are attached on the tables below.

6.5 Budget Sector Envelop

Based on the MTEF Revenue, Expenditure projections and 2023 budget performance, the sector envelops based on discretionary funds were derived which would ultimately form the basis for the issuance of sector Envelops for MTSS preparations and budget ceilings as presented below:
